

**SCGA Partners Championship**  
**Spring Valley CC & The Members Club - Woodcreek**  
**Columbia, SC**  
**March 3-4**  
**Team Entry Fee - \$250**

The Partners Championship has become one of the most popular events conducted by the South Carolina Golf Association. So popular in fact, that in 2009 the SCGA had to expand to two golf courses, Spring Valley Country Club & The Members Club - Woodcreek Course.

The field will play in two separate divisions flip-flopping golf courses on Saturday & Sunday. The Championship Division will conclude play at Spring Valley on Sunday and both divisions will be broken into flights for the final round.

The Partners Championship continues to be one of the main fund raisers for the **South Carolina Junior Golf Association**.

**Eligibility**

Open to 2018 members of the SCGA who are residents of South Carolina. Both players must be at least 18 years of age as of March 3, 2018. Entries may be declined for those individuals who have not had reasonable activity on their club's handicap roster as of the most recent update.

**Entries**

Entries must be received by 5:00 p.m. on February 14, 2018. Field will be limited to 112 teams. Priorities are as follows: (1) Exact teams that participated in 2017 (expires Feb 3). (2) Date of application received at SCGA office. Acceptance will be posted on [www.scgolf.org](http://www.scgolf.org) by Feb. 16. Please be aware that this event is a fundraiser for the SCJGA and all proceeds will be donated to the SC Junior Golf Association.

**Format**

The Field will be split into two divisions based on combined indexes. The Championship Division will play Woodcreek on Saturday & Spring Valley on Sunday – vice versa for the Tournament Division. USGA rules apply, 36-hole event: 18 hole Captain's Choice the first day and 18 hole Modified Texas Scramble for the Final Round. The field will be flighted in each Division for Sunday's final round.
