

# SCGA Four-Ball Championship Musgrove Mill Golf Club May 22-26, 2024

Entry Fee: \$260 Per Team

The Four-Ball Championship is a great attraction as it has become the only Match Play event that the South Carolina Golf Association conducts. With 60 teams starting play, after two days of stroke play qualifying, 32 teams (31 qualifiers and the 2023 Champion) will advance to match play to square off against each other until there is only one team left.

By virtue of being one of the few Match Play events available in South Carolina, this is a great opportunity to play in a format that used to dominate tournament golf.

## Eligibility

Open to 2024 male members of the SCGA who are residents of South Carolina. Both players must be at least 18 years of age as of May 22, 2024. Entries may be declined for those individuals who have not had reasonable activity on their club's handicap roster as of the most recent update.

#### Entries

Entries must be received by 5:00 p.m. on May 1, 2024. Field will be limited to 60 teams. Priorities are as follows: (1) Exact teams that made match play in the 2023 event (expires April 10th). (2) Teams that did not make match play or participate in 2023 with lowest combined handicap indexes (combined indexes as of the March 15<sup>th</sup> update). Changes in partners after acceptance of entry may result in loss of priority. Acceptance will be posted online at www.scgolf.org by May 5th.

# Format

USGA rules apply, 36-hole four ball stroke play qualifier for 18 hole match play. 32 Teams will play for the Title.



#### Schedule

Upon notification of acceptance, each team will be entitled to 1 practice round. Date to begin calling in will be on May 9<sup>th</sup> to schedule practice rounds. Call the Musgrove Mill Golf Shop to make arrangements at (864) 833-6921. Practice times available May 21<sup>st</sup> and prior will be based on a space available basis. Reservations Required. Players will be responsible for a \$35 fee to the Musgrove Mill Golf Club for a practice round.

May 22 & 23	1st and 2nd Qualifying Rounds. (Double Tee/Double Wave)
May 24	First and Second Round Matches.
May 25	Third and Fourth Round Matches.
May 26	Final 18 Hole Match.
